Methamphetamine & opioid overdose deaths are the highest in U.S. (2018)²



29% of 4th graders are chronically absent (2019)⁴



Suicide is the 2nd leading cause of preventable deaths for teens (ages 10-17; 2019)³



10% of children do not live with either parent (2019)⁵



14% of babies born are exposed to drugs (2017)⁶
